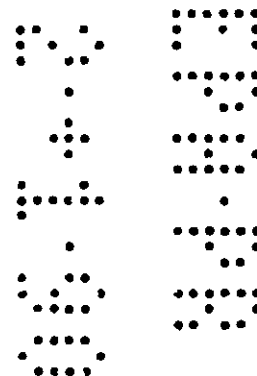
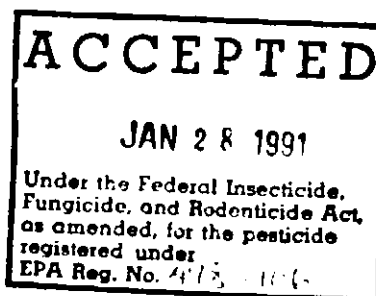

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Do not allow spray to contact food, feedstuffs and water supplies. Thoroughly wash food contact surfaces with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. STATEMENT OF PRACTICAL TREATMENT

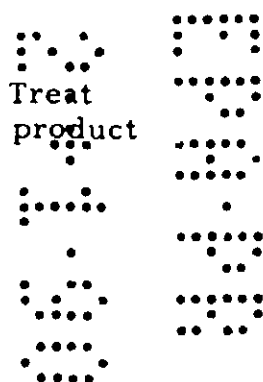
IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person.

IF ON SKIN: Wash contaminated clothing and wash affected areas with plenty of soap and water for at least 15-minutes. Get medical attention if irritation persists.

IF IN EYES: Flush eyes for at least 15-minutes with plenty of water. Get medical attention if irritation persists.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote. This product may cause cholinesterase inhibition. Atropine is antidotal.

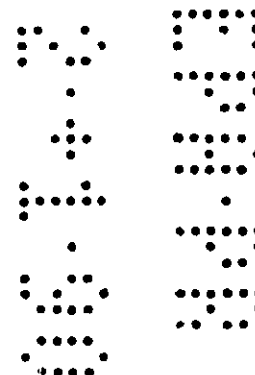

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

SHAKE WELL BEFORE USING.
Hold can upright.

For use in non-food areas Indoors and Outside premises of Hotels, Motels, Homes, Apartment Buildings, Office, Institutional and Storage Buildings, Recreational Buildings, Supermarkets, Restaurants, Bakeries, Boats, Ship Cabins. Also for use in Campers, Mobile Homes, Buses, Automobiles.

Cockroaches, Crickets, Silverfish, Clover Mites, Centipedes, Millipedes, Firebrats, Earwigs, Sowbugs, Spiders, Ants. Use as a spot treatment. When possible spray directly on pests. Apply as a coarse spray around door and window frames, along baseboards and into cracks and crevices. Treat hiding places such as closets, in back of and under appliances, sinks and cupboards in kitchens and bathrooms. Spray moist areas, openings around pipes, under refrigerators and other storage areas. In basements apply to hiding places such as cracks, crevices, lower walls and dark areas. Apply spray until area is wet but not to point of run-off. Repeat as necessary.

Ants. Spray trails, nests and points of entry. Spray directly on ants where possible. Repeat as necessary.

Brown Dog Ticks, Lone Star Ticks, Fleas. Thoroughly apply as a spot treatment to infested areas such as pet bedding and resting quarters; nearby cracks and crevices; along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment of pet area. **Do not treat pets with this product.** Treat pets with registered flea control product before allowing them to enter treated area.

Carpet Beetles. Thoroughly apply as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

PESTS OUT-OF-DOORS

Ants, Clover Mites, Cockroaches, Crickets, Earwigs, Fleas, Flies, Millipedes, Sowbugs, Spiders, Brown Dog Ticks, Long Star Ticks. Spray outside surfaces of buildings, including porches, screens, window frames, ~~walls~~, patios, garages, refuse dumps and other areas where these pests congregate or have been seen. Do not treat or allow the spray to contact plants (lawn, flowering plants, shrubs, trees, evergreens, etc.) because of possible injury. Repeat as necessary.
