## PRECAUTIONARY STATEMENTS

### WARNING

#### Hazards to Humans and Domestic Animals

Never induce vomiting or give anything by mouth to an unconscious person. If on Skin: Wash contaminated clothing and wash affected areas with plenty of soap and water. If In Eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated. NOTE TO PHYSICIAN: This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.

Cockroaches, Crickets, Silverfish, Clover Mites, Centipedes, Millipedes, Firebrats, Earwigs, Sowbugs, Spiders: Use as a spot treatment. When possible spray directly on pests.
