

1. CONNECT WAND HOSE TO POWER PUMP BOTTLE. Unwrap the wand. Unscrew, and discard the [black] cap protecting the bottle opening. (graphic). Push the clear tube down through the small opening on the bottle. Tightly screw the [green] hose connector cap onto the bottle. (graphic).

Make sure the [Green] button on the wand "OFF" or "UP" before pressurizing (graphic).
