#### SHAKE WELL BEFORE USING

1. Cover exposed food, dishes and food handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. **Put out all flames and pilot lights.** Close exterior doors and windows.
2. Tilt top of can away from face. Press valve all the way down, hooking the catch.
3. Then place fogger on stand, table or floor in center of room with the valve locked open, with several layers of newspaper or pad under fogger. Leave treated area for 2 hours.

After 2 hours, open all doors and windows, turn on air conditioners and fans and let the treated area air out for 30 minutes.

Repeat spraying in two to four weeks if necessary. Use one can for each 6,000 cubic feet of unobstructed area. **Do not use this can in an area less than 100 cubic feet.** Use additional cans for remote rooms or where free flow of mist is not assured.

**TO KILL FLEAS OR TICKS:** Remove and destroy pet's old bedding. Apply this product as for other insects. Put fresh bedding in pet's quarters after treatment. Treat dogs and cats with a registered flea or tick control product (such as ...) before allowing them to enter treated areas.

### STORAGE AND DISPOSAL

Store in a cool, dry area away from heat or open flame. Discard container in trash. Do not puncture or incinerate.

### PRECAUTIONARY STATEMENTS

#### Hazards to Humans and Domestic Animals
