Dear Ms. Mah:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. You must revise the disposal statements in accordance with the latest Agency guidance for residential/household pesticide products given in PR Notice 2001-6. A copy of the PR Notice is enclosed. Since this product is packaged in pressurized containers, the appropriate disposal statements are as follows:

Do Not Puncture or Incinerate!

If empty: Place in trash or offer for recycling if available.

If partly filled: Call your local solid waste agency or [toll fee number which meets the criteria in paragraph II.E. of PR Notice 2001-6] for disposal instructions.

2. You must submit or cite the efficacy data described in item 1 of my September 5, 2001 letter to you. I understand that you are preparing a Data Matrix which includes the data that support the efficacy of this product and will forward it to EPA for review when it is completed. Upon receipt of the Data Matrix, we will review the efficacy data you cite/submit to determine if they support this product. Depending on the outcome of our review, additional label revisions may be required.

OPTIONAL MARKETING LANGUAGE

TO USE THIS PRODUCT CORRECTLY

DO NOT use more than one logger per room.

DO NOT use in small, enclosed spaces such Graphic showing how NOT to use

as closets, cabinets, or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. (Graphic showing how NOT to use)

TURN OFF ALL IGNITION SOURCES such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.

BEFORE YOU FOG

Cover or removed exposed food, dishes and food preparation equipment. Open cabinets and doors. Shut off fans and air conditioners and turn off all ignition sources as directed above. Remove pets including birds. Cover and turn off fish tanks. Close outside doors and windows.

TO START FOGGING

- Place several layers of newspaper or paper towels on a table, stand or floor in center of room. Cover waxed wood floors and waxed furniture in the immediate area surrounding the fogger. Newspapers may be used.

- SHAKE WELL BEFORE USING. Tilt can top away from face. Press valve all the way down, hooking the catch.

 Set can on newspaper or paper towels and leave the premises immediately. Do not re-enter treated area for two hours.

AIRING OUT

After two hours, open all doors and windows, turn on air conditioner and fans and air out for 30 minutes. Re-apply every two to four weeks if needed.

NOTE: When treating for fleas or ticks, clean and treat pet sleeping areas. Also treat dogs and cats with a flea and tick control product registered for use on pets before allowing them to enter the treated areas.

STORAGE AND DISPOSAL


