

PEROLIN ALGAE PREVENTIVE 902

Perolin Algae Preventive 902 - for controlling growth of algae or slime forming bacteria in evaporative condensers and cooling tower systems. **DOSAGE**

USE 4 LIQUID OUNCES OF 902 PER DAY PER 10 TONS OF REFRIGERATION, OR 4 LIQUID OUNCES PER DAY PER 480 GALLONS OF MAKEUP WATER, WHEN THE BLEEDOFF RATE IS 1 GAL. PER HOUR PER TON. THE DAILY DOSAGE MAY BE DILUTED TO ANY CONVENIENT VOLUME AND FED, FOR EXAMPLE, THROUGH A 5 GAL. CAN OR LARGER DRUM EQUIPPED

2. SHOCK TREATMENT

APPLY WHEN INDICATIONS OF ALGAE GROWTH OR SLIME FORMING BACTERIA APPEAR, OR ON A PERIODIC FEEDING SCHEDULE ON A SLUG BASIS - ALL AT ONCE - AT THE RATE OF ONE-HALF PINT PER 10 TONS OF REFRIGERATION OR ONE-HALF PINT PER 50 GALLONS OF WATER. FREQUENCY OF SHOCK APPLICATION IS DEPENDENT UPON VISUAL OBSERVATION AND SEVERITY OF ORGANIC GROWTHS. NORMALLY, WEEKLY SHOCK DOSAGES WILL SUFFICE.

WITH A PETCOCK OR NEEDLE VALVE, INTO SUMP OF SYSTEM.
