**INDUSTRIAL RECIRCULATING WATER  
COOLING TOWERS AND  
EVAPORATIVE CONDENSERS**

Dosages for industrial recirculating water cooling towers or evaporative condensers will depend on the condition of the system prior to treatment initiation. Systems which are heavily contaminated should be cleaned first. Apply Perolin Algae Preventive 927 to the cleaned system or when growth is first noticed according to the following schedule:

**Initial Dose:** Apply 8 ounces of product per each 1000 gallons of water (60 ppm) in the system. This dose may be repeated once, twice, or three times weekly or as required to control the growth of slime-forming organisms.

**Subsequent Dose:** When microbial control is evident, add 4 fluid ounces of Perolin Algae Preventive 927 per 1000 gallons of water (30 ppm) in the system daily or every other day as needed.

Apply at a point in the system where uniform mixing and even distribution will occur, such as the cooling tower basin or sump.
