The removal of Isopropanol and Potassium Tall Oil Soap from the active ingredients and inclusion of them in the inert ingredients is in compliance with the current EPA Label Improvement Program and is therefore acceptable. The revised Confidential Statement of Pormula satisfactorily fulfills our requirements in this regard.
