Dimethyl Benzyl Ammonium Chlorides  
INERT INGREDIENTS: 95.0%

A multi-purpose cleaner disinfectant and deoderant for use on any and all surfaces unaffected by plain water.

For use on all hard or resilient floor surfaces, windows, walls, fixtures, sinks, drinking fountains, and on any surface which requires sanitizing. Ideal for use in hospitals, clinics, schools and other institutions.

DIRECTIONS FOR USE:

General Cleaning and Disinfecting: In hospitals and other institutions, use a solution of 2 ounces to the gallon of water. Use clean cloth or mop for application, or use in floor machine in conventional manner.

Sinks, Toilet Bowls and Urinals: For proper disinfectant of these surfaces use a solution containing 400 ppm of SCI-23. This is equivalent to  $\frac{1}{2}$ -oz. per gallon of water. Wet surface first, then sprinkle SCI-23 liberally on surfaces to be cleaned; let stand and then flush equipment.

Food Plant Equipment: Use a solution of 2 ounces to the gallon of warm water and then follow with a clean water rinse. Difficult surfaces, such as cutting boards or meat-cutting boards should be scrubbed with a solution of 4 ounces to the gallon of warm water. Rinse thoroughly with clean water before re-use. Mold control on walls, ceilings, and other surfaces in food plants can be accomplished by cleaning with a solution of four ounces to the gallon of warm water. Do not rinse these surfaces but simply wipe dry with a clean cloth. To aid in the control of athlete's foot fungi on locker room floors, shower rooms, and floors adjacent to swimming pools. Clean these areas with a solution of 4 ounces to the gallon of water.
