HOW TO OPERATE: Remove protective cap. Direct nozzle toward area to be sprayed and press valve button down. Keep bomb nozzle at least 3 feet from all surfaces.

TO KILL FLIES, MOSQUITOES, WASPS, GNATS, FLYING MOTHS: Close doors and windows to confine aerosol. Direct the aerosol mist to all parts of room. Apply for 3 to 5 seconds per 1,000 cu. ft. of space. For best results, keep room closed for 15 minutes after each treatment.

TO KILL SILVERFISH, ANTS, ROACHES, CRICKETS: Direct spray towards all insects in cracks, crevices, underside of shelves, closets and insect trails. Pay particular attention to pantries, kitchens and cellars. Repeat application whenever insects re-appear.

OUTSIDE AREAS: For temporary relief from flies and mosquitoes, direct spray to ground and bushes. Repeat application as required.
