

4. Revise the first part of your Practical Statement to read as follows:
"STATEMENT OF PRACTICAL TREATMENT: If ~~swallowed~~ call a physician or Poison Control Center immediately. ~~Drink 1 to 2 glasses of water and induce vomiting xxxxx.~~" (xxxxx = add. ~~directions~~).

Note the above precautionary text must appear on both the outer and inner labels. If the inside label container is to small to fit all of the label text you may replace the "Directions" paragraph with the statement "See carton for directions" and carry the Directions for use on the outside carton label only.

5. Delete the claims "Made and used by exterminators" and "SMD-CLOUD is a professional formula made and used by professional exterminators" on both the the box and small inner label. These statements are unacceptable since they are false or misleading statements concerning the effectiveness of the product.
6. Expand the heading DIRECTIONS to DIRECTIONS FOR USE and relocate underneath this heading "It is a violation of Federal law to use this product in a manner inconsistent with its labeling."

[NOTE- Quotation marks are not to be reproduced on your labeling.]

7. The limitation of the sale period should appear as "Not to be sold after November 30, 1986." and should appear on the front panel of both the inner and outer label.
8. Revise "cover tightly or remove any food in rooms to be treated" to read "Food should be removed or covered tightly during treatment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. When using the product in commercial food preparation areas, apply only when the facility is not in operation."
9. Under "Directions For Use" change "For Household Use" to "For Indoor Use".
10. Refer to the enclosed type size guide for assistance in selecting print sizes for label elements with minimum size requirements.
11. On the front panel add "fleas" to the statement, "Kills exposed roaches, ants, waterbugs, fleas - and xxxx."

Submit five copies each of the box and inner labels bearing the above revisions prior to release for shipment. Note that after April 15, 1985 the subject product may not be distributed, offered for sale, held for sale, sold, shipped or delivered for shipment by you unless the labeling complies with the above revisions.

A stamped copy of the label is enclosed for your records.

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided the following revisions are made prior to release for shipment of stocks bearing the amended labeling:

1. The front panel of the label must bear the following:

KEEP OUT OF REACH OF CHILDREN

CAUTION

2. The limitation of the sale period should appear as "Not to be sold after November 30, 1986" and should appear on the front panel of the label.
3. We suggest the following revised Statement of Practical Treatment, however, if your toxicological data suggests otherwise, please submit a draft Statement of Practical Treatment for approval:

STATEMENT OF PRACTICAL TREATMENT:

If swallowed - Call a physician or Poison Control Center immediately. Drink one or two glasses of water and induce vomiting by touching the back of throat with a finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

If inhaled - Remove victim to fresh air. Apply artificial respiration if indicated.
