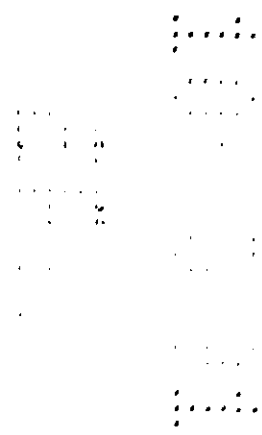

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

Remove protective cap. Hold can at least 12 inches away. Point valve in desired directions and press button to spray. Do not spray in enclosed areas. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness. For chiggers, also apply to shoe tops, socks and ground openings of clothing.

After returning indoors, wash treated skin with soap and water. Wash treated clothing.

WARNING: Do not apply over cuts, wounds, or irritated skin. Do not apply to eyes and mouth and do not apply to the hands of young children. Do not spray directly on face. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent with you.

Avoid contact with plastics such as eyeglass frames, watch crystals and such fabrics as acetate rayon. Do not spray on furniture finishes or painted surfaces. Do not puncture or throw this container near fire.

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not re-use empty container. Wrap container and put in trash collection. Do not incinerate or puncture.
