Contact with skin, eyes or clothing should be avoided. Wash thoroughly with soap and warm water after handling. If poisoning occurs, get prompt medical aid. Avoid contamination of food, utensils, food preparation areas. Do not use in commercial food preparation areas or edible products areas of food processing plants. Avoid contamination of fish ponds. Remove pets from area before spraying.

To Physician - Atropine sulfate is antidotal.

PHYSICAL & CHEMICAL HAZARDS

FLAMMABLE: Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting.

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Remove protective cap from top of can. Hold upright, point opening in valve in desired direction for spray. To release spray, press valve downward or push valve forward.

FOR OUTDOOR USE: Hornets, Yellow Jackets, Wasps, Bees. Aim valve at nest where insects are known to be inside. Press valve all the way down until the area is saturated with spray. Repeat as necessary. Apply after dark when all of the insects have returned to the nest. The treated surface will have a residual killing action and prevent reinfestation for weeks. In the event the insecticide film becomes ineffective due to rain and other causes, repeat treatment.

Ants: Spray hills and runways. Repeat as necessary.

Spiders, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sowbugs, Brown Dog Ticks. Spray infested areas thoroughly including outside surfaces of screen frames, doors, window frames, foundations, patios or other places where insects may enter or harbour. Repeat as necessary.

FOR INDOOR USE: Roaches, Crickets, Ants, Spiders, Centipedes, Silverfish, Waterbugs. For use indoors spray thoroughly the infested cracks, baseboards, behind shelves, book cases and cabinets around plumbing, cracks and crevices of sinks and other dark and moist places where infestation of these insects occur.

When using outdoors, do not spray vegetation. When using indoors, avoid wetting asphalt tile, rubber and plastic materials. Do not use as a space spray.

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not reuse empty container. Wrap container and put in trash.
