The following amendment submitted in connection with registration under FIFRA section 3(c)(7)(A) is acceptable with conditions listed below.

### **Proposed Amendment**

Adding Non-Food Contact Sanitizing Claims

#### **Conditions**

Revise the label as follows:

- 1. According to PR Notice 2001-1, First Aid Statements, you must add the statement, "Have product container or label with you when calling a poison control center, doctor, or going for medical treatment." This statement must appéar after the "First Aid" heading.
- 2. The 4<sup>th</sup> statement under "Physical Hazards" must be brought into compliance with PR Notice 2000-5, Mandatory Labeling, by deleting the term, should, and stating "must."
- 3. Revise the HIV directions to read as follows:

Kills HIV-1 (AIDS Virus) on precleaned environmental surfaces objects previously soiled with blood and body fluids in health care settings or other settings in which there is an expected likelihood of soiling of inanimate surfaces/ objects with blood or body fluids and in which the surfaces/ objects likely to be soiled with blood or body fluids can be associated with the potential
