1. Under "Directions for Use," the statement "Kills HIV-1 (AIDS Virus) . . ." must be placed immediately below the statement "Special Instructions for . . . ."
2. Delete the word "Stuff" in the precautionary statements.
3. On the back panel, move the paragraph "After surface is cleaned . . . prior to wiping," so that it appears after the section "Clean object to be sprayed . . . until surface is wet."

PERSONAL PROTECTION: When handling items soiled with blood or body fluids use appropriate barrier protection such as disposable latex gloves, gowns, masks or eye coverings.

Allow spray to dry without wiping or allow spray to contact treated surface for a minimum of ten minutes prior to wiping.

This disinfectant spray is a powerful germicidal that kills Staphylococcus aureus, Salmonella choleraesuis, and Pseudomonas aeruginosa.

Use to disinfect urinals, toilet seats, wash bowls, shower stalls, telephones, empty hampers, diaper pails, athletic equipment, light switches, garbage cans and lockers.

Clean object to be sprayed using usual cleaning methods. Hold dispenser upright and spray six inches from surface until surface is wet.

It is also effective against fungi such as *Trichophyton interdigitale* (causes of ring worm or athletes foot), not intended to topical application to the body.

**DIRECTIONS: FOR CONTROL OF MOLD & MILDEW**

Prevent mold and mildew on hard surfaces such as ceramic, metal, glass in basement closets, attic storage areas, summer cottages.

Clean object by usual cleaning methods. Hold dispenser upright and spray six inches from surface until surface is wet. Repeat application when new growth appears.

**DIRECTIONS: FOR SPACE DEODORIZER & AIR FRESHENER**

Use to deodorize meeting room, class room, kitchen, bathroom, sick room, living room, and churches.

Hold can upright and point valve opening away from face. Spray upwards for three seconds into corner as well as center of room, filling room with mist.
