Cover exposed food, dishes, and food handling equipment. Open cabinets, drawers, closets and doors to area that will be treated. Shut off fans and air conditioners. Put out all flames and pilot lights. Then close doors and windows to prevent escape of spray mist. Point valve opening away from face and eyes when spraying. Use no more than one unit for each 6,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before re-entry.

To operate valve: To lock valve in open position for automatic discharge, press valve button all the way down, locking the catch. Then place fogger on stand or table in the center of the room with valve locked in the open position. Place several layers of newspaper or pad under fogger. Leave building at once and keep building closed for four hours before airing out. Open all doors and windows and allow fresh air to circulate for 30 minutes. Repeat spraying in two weeks or when necessary.

To Kill Ticks: Destroy Pet's old bedding and replace. Use product as above. Treat dogs and cats with registered tick control.... product prior to re-entry.

To Kill Fleas: Follow cirections for ticks but use one unit per 1,500 cubic feet of room space.
