Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness. For chiggers, also apply to shoe tops, socks and ground openings of clothing.

After returning indoors, wash treated skin with soap and water. Wash treated clothing.
