FOR OUTDOOR USE: Hornets, Wasps, Yellow Jackets, Bees: DO NOT USE AS A SPACE SPRAY. It is preferable to apply this product after dark when all the insects have returned to the nest. Aim valve opening at the nest with the wind at your back. Do not stand directly under the nest. Press valve all the way down until the area is saturated with spray. Repeat as necessary. This treated surface will have a residual killing action and prevent reinfestation for weeks. In the event the insecticide film becomes ineffective due to rain and other causes, repeat treatment.

Ants: Spray hills and runways. Repeat as necessary.

Spiders, Clover Mites, Crickets, Earwigs, Fleas, Millipedes, Sawbugs, Brown Dog Ticks: Spray infested areas throughly including outside surfaces of screen frames, floors, window frames, foundations, patios or other places where insects may enter or harbour. Repeat as necessary.
