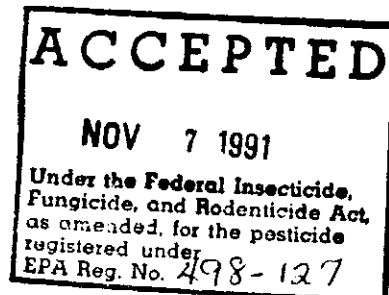

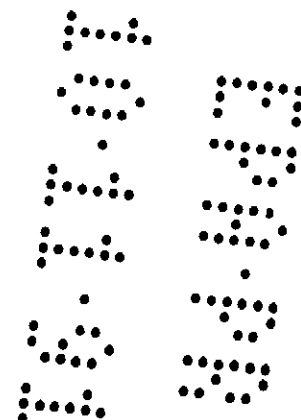

## PRECAUTIONARY STATEMENTS

## HAZARDS TO HUMANS &amp; DOMESTIC ANIMALS

## C A U T I O N

Harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing vapors or spray mist. Avoid contact with eyes, skin or clothing. Do not allow spray to contact food, feed-stuffs and water supplies. Thoroughly wash food contact surfaces with soap and water if they become contaminated by application of this product. Do not allow children or pets to contact treated surfaces until spray has dried. Remove pets and cover fish bowls (tanks) before spraying. Do not apply this product in conduits, motor housings, junction and switch boxes of other electrical equipment because of possible shock hazard. Do not use this product in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared. Do not use in serving areas while food is exposed.

## STATEMENT OF PRACTICAL TREATMENT

If swallowed: Do not induce vomiting. Get immediate medical attention.  
If inhaled : Remove from contaminated atmosphere. Give artificial respiration and oxygen if necessary.  
If on skin: In case of contact, remove contaminated clothing and wash skin with soap and water.  
If in eyes: Flush eyes with plenty of water.  
NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

## ENVIRONMENTAL HAZARDS

This product is toxic to fish, birds and other wildlife. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.

## PHYSICAL &amp; CHEMICAL HAZARDS

Contents under pressure. Keep away from heat sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 120°F may cause bursting.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

## SHAKE WELL BEFORE USING

For use in non-food areas, Indoors and Outside premises of Hotels, Motels, Homes, Apartments, Office, Institutional, Storage and Recreation Buildings, Supermarkets, Restaurants, Bakeries, Ship Cabins, also for use in Campers, Mobile Homes.

**CONTACT SPRAY-KILLS AND REDUCES INFESTATIONS OF** Cockroaches, Crickets, Silverfish, Clover Mites, Centipedes, Millpedes, Firebrats, Earwigs, Sowbugs, Ants, Spiders, Fleas: Use as a spot treatment. When possible, spray directly on nests to reduce infestations. Apply as a coarse spray or with a paint brush into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators and other appliances, baseboards and storage areas. Apply spray until area is wet, but not to the point of run-off. Repeat as necessary.

**ANT:** To kill ants, spray trails, nests and points of entry within buildings and homes. Spray directly on ants where possible. Repeat as necessary.

**FLEAS, BROWN DOG AND LONE STAR TICKS:** Thoroughly apply as a spot treatment to infested areas such as pets beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor covering where these pests may be present. Old bedding of pets should be removed and replaced with clean fresh bedding after treatment. **DO NOT TREAT PETS WITH THIS PRODUCT.** Treat pets with a product registered for animal application to control the source of flea and tick infestation.

**CARPET BEETLES:** Thoroughly apply as a spot treatment along baseboards and edges of carpeting, under carpeting, rugs and furniture, in closets and on shelving, and wherever else these insects are seen or suspected.

**RESIDUAL SPRAY:** Aids in the control of Cockroaches, Crickets, Silverfish, Centipedes, Millpedes, Earwigs, Sowbugs. Kills up to 4 weeks. Apply on baseboards, cracks and crevices, around door and window frames, and other hiding places such as closets, in back of and under appliances, sink and cupboards in kitchens and bathrooms in basements, apply in hiding places in cracks and crevices, lower walls and dark places. Apply as a coarse wet spray in a 6 inch band until area is thoroughly wet but not to the point of run-off. Treat on a monthly basis or as necessary.

#### PESTS OUT-OF-DOORS

**HOUSEFLIES, MOSQUITOES, OUTDOORS:** For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around light fixtures on porches, in garages, and other places where these insects alight or congregate. Repeat as necessary.

**ANT, BROWN DOG TICKS, CRICKETS, FLEAS, AND EARWIGS OUTDOORS:** For treatment of localized infestations of these insects in outdoor areas where there are weeds or bushy non-crop areas, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat application as infestations warrant and as reinfestation occur.

#### STORAGE AND DISPOSAL

**STORAGE:** Do not use or store near heat or open flame. Keep away from food, feedstuffs, and domestic water supplies.

**DISPOSAL:** Do not re-use empty container. Wrap container and put in trash collection.
