## PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS

**CAUTION:** Avoid inhalation or ingestion of spray. Wash hands thoroughly after use. Avoid contamination of feed and foodstuffs.

## HAZARDS TO DOMESTIC ANIMALS

Do not spray directly on eyes, mouth or genitalia of pets. Do not treat or cause exposure to kittens or puppies less than four weeks old.

## STATEMENT OF PRACTICAL TREATMENT

**IF INHALED:** Remove affected person to fresh air. Apply artificial respiration if indicated. Do not give anything by mouth to an unconscious person.

**IF IN EYES:** Flush with water for 10-15 minutes. Contact a physician if irritation persists.

**IF ON SKIN:** Wash affected areas immediately with soap and water. Contact a physician if irritation persists.

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

## SHAKE WELL BEFORE USING

Remove protective cap, hold container upright and spray from a direction of 12 to 15 inches.

**FLEAS:** (Adults and Larvae) and **TICKS:** Remove and thoroughly clean or destroy pet bedding. Spray pet sleeping quarters, bed, entire floor and floor covering, with special attention to cracks and crevices around baseboards and window and door frames. Infested upholstered furniture may also be treated with this product. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use.

This product may be used on pets. Start at the tail, stroke against the lay of the hair, spraying the parted fur in short bursts, directly behind the hand to insure penetrating the coat. Dampen the fur up to the head. Repeat applications weekly if necessary to control infestations.

**NOTE:** Not recommended for use on kittens or puppies less than four weeks old.

**COCKROACHES, WATERBUGS, SILVERFISH, CRICKETS, SPIDERS:** Spray into hiding places such as cracks and crevices, behind sinks, cabinets, along baseboards and floors, around drains and plumbing, hitting insects with spray whenever possible. Repeat treatment if necessary.

**ANTS:** Spray trails, nests and points of entry. Spray on ants where possible. Repeat if necessary.

**CARPET BEETLES:** Spray directly on beetles, baseboards, floors, shelves and carpets. Repeat treatment if necessary.

**STORAGE:** Store in original container in a cool dry place inaccessible to children and pets and away from heat or direct sunlight. Protect from freezing.

**DISPOSAL:** Do not reuse empty container. Wrap container and put in trash.
