The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the Pyrethrins, Permethrin, and MGK-264 REDs, and has concluded that your submission is acceptable.

NOTE: This product is **not** being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on non-refillable containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.



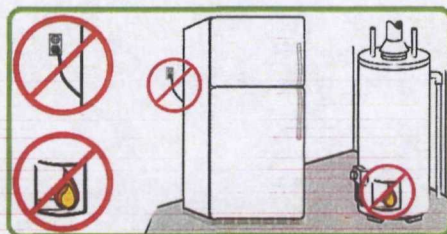

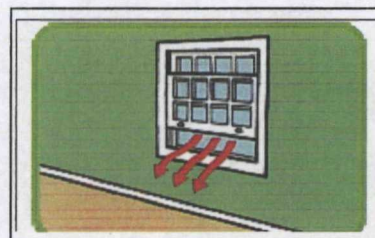


Remove or cover exposed food and drinking water before application. Remove or cover dishes, utensils, food processing equipment, and food preparation surfaces, or wash them before use. Remove pets, birds, and cover fish aquariums before use. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face and eyes when releasing. Do not remain in the area during treatment and ventilate thoroughly before reentry.

TO START FOGGING

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. **Vacate the treated house, individual apartment unit, or other structure immediately.** Fill out and place hangtag on the door to the treated area to alert family and others with access to the treated area not to enter for 4 hours.

AIRING OUT



Do not Reenter for 4 Hours. Leave building at once and keep building closed for 4 hours before airing out. Open all doors, windows and vents and allow to air for 2 hours. If an odor is still detected, additional ventilation is required. Repeat spraying in 2 weeks or when necessary.

TO KILL TICKS & FLEAS: Old bedding should be removed and replaced with fresh, clean

bedding after treatment. Pets should be treated with a registered product for flea and tick control in conjunction with this treatment.
