PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**WARNING**

Harmful if swallowed. Contains petroleum distillate. Do not induce vomiting because of aspiration pneumonia hazard. Do not breathe vapors or spray mist. Causes slight eye irritation. This product is toxic to fish and other aquatic animals. Do not apply directly to any body of water. Do not contaminate water by cleaning of equipment or disposal of wastes.

PHYSICAL OR CHEMICAL HAZARDS

Contents under pressure. Keep away from heat, sparks, and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130 F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For Control of Wasps and Hornets: It is preferable to apply this product in the evening after all the insects have returned to the nest. Aim valve opening at the nest and depress button, continuing to spray until the nest is soaked with the spray. Repeat as necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and wrap container in several layers of newspaper and discard container in trash. Do not incinerate or puncture.
