

FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

READ ALL DIRECTIONS BEFORE USING THIS PRODUCT

To repel the listed insects, apply just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid overexposure. Frequent reapplication and saturation are unnecessary for effectiveness. Do not spray directly on face. Apply sparingly around ears. **Do not use on**

children under 2 years old. Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Do not apply over cuts, wounds or irritated skin. Repeat as needed. For ticks and chiggers, also apply to shoe tops, socks and around openings in clothing. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, discontinue use, wash treated skin and call your local poison control center. If you go to a doctor, take this product with you.

Do not apply to or near plastics, leather, acetate rayon, spandex or colored fabrics other than nylon. If applying to clothing, spray lightly. Avoid spraying on or near nail polish, watch crystals, eyeglass frames, furniture, and painted or varnished surfaces, including bicycles and automobiles. Excess spray drifting onto grass or foliage will cause discoloration, but will not otherwise damage the plant.
