Dear Ms. Hernandez:

The proposed amendment to the registration of the product cited above under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended revising the label by adding the claim, Provides Continuous Protection That Lasts Up To 5 Hours, and revising the label in response to the DEET RED is acceptable subject to the following comments:

1) In the Ingredients Statement change the declaration of the active ingredient, deet, to read:

Deet.....15.00%

2) Add the following to the First Aid section:

If you suspect a reaction to this product:

- \* Discontinue use;
- \* Take off contaminated clothing;
- \* Rinse skin immediately with plenty of water for 15-20 minutes;
- \* Call a poison control center or doctor for treatment advice.

3) Add the statement, "For additional information in case of emergency call toll free(insert Telephone Number), to the First Aid block.

4) The statement, "Have the product container or label with you when calling a poison control center or doctor, or going for treatment.", should remain in the First Aid statement.

5) Change the Precautionary Statements to read as follows:

“Causes substantial but temporary eye injury. Harmful if swallowed. Do not get in eyes. Use of this product may cause skin reactions in rare cases. Wash treated clothing before wearing it again. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet.”

6) Add the following Note To Physician statement to the label:

“NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.”



This product is not being re-registered at this time. Product specific efficacy data will be required. Once the efficacy guidelines are in place, you will be notified of the efficacy requirements.

Also, to be eligible for re-registration, the product must be packaged in containers utilizing a concave trigger to help aim the product or other comparable mechanism that will ensure that the product will not be inadvertently sprayed in the eyes.

A stamped copy of the revised label is enclosed for your records. The label reviewed for comments in this letter was that submitted with your application dated October 15, 2002. Submit two copies of the revised finished label before the product is released for shipment under this amended label.

The CSFs dated July 12, 2001 for the basic and alternate formulations are acceptable and have been made a part of the file for this product.

To repel insects listed on the front panel, hold can at least 12 inches away. Point opening in desired direction and press top to spray. **Do not spray in enclosed areas. Do not use under clothing. Use just enough repellent to cover exposed skin and/or clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness.** For chiggers, also apply to shoe tops, socks and around openings of clothing.

After returning indoors, wash treated skin with soap and water. Wash treated clothing.

Do not apply over cuts, wounds or irritated skin. Do not spray directly on face. To apply to face, spray into hands and rub on. Do not apply near eyes or mouth. Apply sparingly around ears. **Do not use on children under 2 years old.** Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, discontinue use, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent with you.

Avoid contact with plastics such as eyeglass frames and such fabric as acetate rayon.
