In addition to rapid initial kill, this product stays on treated surfaces and kills insects many weeks after the spray deposit has dried.

HOW TO USE: Unlike most pressurized residual sprays, SprayPak Wasp Long Range Jet Spray, Formula 2, shoots a lethal stream of spray allowing the user to direct the spray to a distance of up to 20 feet. Cracks, crevices, and hard-to-reach locations can be reached without bending, crawling, or climbing. Spray infested surfaces until wet, moving the spray stream rapidly to prevent excessive wetting of surfaces, and waste of material.

OUTDOOR USE: ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, FLIES, HORNETS, MILLIPEDES, MOSQUITOES, SOWBUGS, WASPS, BEES, YELLOW JACKETS AND BROWN DOG TICKS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray runways. For control of wasps and hornets apply after dark when all of the insects have returned to the nest. Repeat as necessary. Do not spray vegetation.
