Dear Ms. Hernandez:

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable, subject to the comments listed below.

- 1. Revise your "Precautionary Statements" section to read: "Harmful if absorbed through the skin or inhaled. Avoid breathing vapor or spray mist. Causes moderate eye irritation. Avoid contact with skin, eyes, or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse."
- 2. Move the statements "Do not use in commercial food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared, processed or stored. In the home, all food-processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets, birds, and cover fish aquariums before spraying." to the "Directions for Use" section of your label.
- 3. Revise your "First Aid" section to <u>include</u> the following statements:

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice".

Submit two (2) copies of your final printed labeling before you release the product for shipment. A stamped copy of the label is enclosed for your records. If you have any questions, please call Dr. William Sproat of my team at 703-308-8587.

SHAKE WELL BEFORE USE

This product will kill ants, cockroaches, confused flour beetles, crickets, fleas, houseflies, mosquitoes, rice weevils, saw-toothed grain beetles, small flying moths, sow bugs, and brown dog ticks.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5 ft. x 5 ft. or smaller; instead, allow fog to enter from other rooms. TURN OFF ALL IGNITION SOURCES SUCH AS PILOT LIGHTS (SHUT OFF GAS VALVES), OTHER OPEN FLAMES, OR RUNNING ELECTRICAL APPLIANCES THAT CYCLE OFF AND ON (i.e., REFRIGERATORS, THERMOSTATS, ETC.). Call your gas utility or management company if you need assistance with your pilot lights.

KEEP CONTAINER UPRIGHT

Cover exposed food, dishes and food-handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each 6,000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before reentry.

TO OPERATE VALVE: Place several layers of newspaper or pad on stand or on table in the center of the room. Point valve opening away from face. To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open. Leave building at once and keep building closed for 2 hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying if necessary, but no sooner than within 2 weeks.

TO KILL BROWN DOG TICKS & FLEAS: Destroy pets' old bedding and replace with

clean, fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.

STORAGE & DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not reuse empty container. This container may be recycled in one of the limited number of aerosol recycling centers in the country.
