



Do not use in a room 5 ft x 5 ft or smaller instead allow fog to enter from other rooms. TURN OFF ALL IGNITION SOURCES SUCH AS PILOT LIGHTS (SHUT OFF GAS VALVES), OTHER OPEN FLAMES, OR RUNNING ELECTRICAL APPLIANCES THAT CYCLE OFF AND ON (1 e, REFRIGERATORS, THERMOSTATS, ETC.) KEEP CONTAINER UPRIGHT


Cover exposed food dishes and food handling equipment. Open cabinets and doors to area to be treated. Shut off fans and air conditioners. Close doors and windows. Point valve opening away from face when releasing. Use one unit for each 6 000 cubic feet of unobstructed area. Do not remain in the area during treatment and ventilate thoroughly before reentry.

TO START FOGGING

TO OPERATE VALVE Place several layers of newspaper or pad on stand or on table in the center of the room Point valve opening away from face. To lock valve in open position for automatic discharge press the valve button all the way down hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open. Vacate the treated house, individual apartment unit, or other structure immediately. Fill out and place hangtag on the door to the treated area to alert family and others with access to the treated area not to enter for 4 hours.

AIRING OUT





Do Not Reenter for 4 Hours Keep building closed for 4 hours before airing out then open windows vents and doors for 2 hours. If an odor is still detected additional ventilation is required. Repeat spraying if necessary but no soone than within 2 weeks.

TO KILL BROWN DOG TICKS & FLEAS Destroy pets old bedding and replace with clean fresh bedding after treatment is completed. Use product as above. Pets should be treated with a registered flea and tick control product prior to reentering treated premises.
