SHAKE WELL BEFORE USE - KEEP CONTAINER UPRIGHT

Do not remain in enclosed area during use. Keep out of treated area for four hours. Ventilate enclosed area for 30 minutes before reoccupying. Remove pets and birds and cover and turn off fish aquariums before spraying. Avoid contamination of food or feedstuffs.

Apply this product only as specified on this label. Reapply as needed. Do not use in food-feed-handling establishments, restaurants or other areas where food/feed is commercially prepared or processed.

DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets or under counters or tables. Do not use in a room 5'x 5' or smaller, instead, allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames, or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights.

Open cabinets, cupboards, drawers, closets and doors in areas to be treated. REMOVE or cover exposed foods, dishes, utensils, food-processing equipment and surfaces. REMOVE pets and birds, and cover and turn off fish aquariums before spraying. Turn off air flow systems in aquariums. COVER waxed wood floors, waxed furniture and stereo or other plastic dust covers in the immediate area surrounding the fogger. (Newspaper may be used.) CLOSE outside doors and windows. SHUT OFF fans and air conditioners. Do not remain in the area during treatment and ventilate thoroughly before reentry.

TO OPERATE VALVE: To lock valve in open position for automatic discharge, press the valve button all the way down, hooking the catch. Then place fogger on stand or table in the center of the room with valve locked open, placing several layers of newspaper or pad under fogger. Leave building at once and keep building closed for 4 hours before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in 2 weeks or when necessary.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from heat or open flame.

DISPOSAL: Do not reuse empty container. This container may be recycled in one of the limited

number of aerosol recycling centers in the country. Before recycling, empty the can by using the product according to the label. DO NOT PUNCTURE! If recycling is not available, wrap the container and discard in the trash.
