

HOW TO USE: To kill Ants, Cockroaches, Crickets*, Centipedes*, Silverfish*, Firebrats*, Earwigs, Sowbugs*, Pillbugs* and Spiders*: Spray to contact as many insects as possible while thoroughly spraying all areas where the pests are suspected of hiding, such as the floor and baseboard areas of the pantry, food and pet food storage areas, cracks and crevices in walls and flooring materials, under sinks, under stoves, under refrigerators, around garbage containers, cabinets, door and window sills, thresholds, door and window frames, around floor drains, storage and utility installation areas, wall voids and where plumbing goes through the walls.
