The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the pyrethrins, piperonyl butoxide (PBO) REDs, and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on <u>non-refillable</u> containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

- 1 Basic CSF, dated 9/10/09

The only CSF contained within the application package is marked "Alternate 1" and is dated 9/10/09. Since the product chemistry review only makes mention of a single Basic CSF dated 9/10/09, it is assumed that this "Alternate 1" CSF was marked incorrectly, and it has now been updated as the "Basic" CSF for the product.

A copy of your label stamped "Accepted" is enclosed along with copies of the acute toxicity and product chemistry reviews completed for the subject product. Products shipped after 12 months from the date of this amendment or the next printing of the label whichever occurs first, must bear the new revised

label. Your release for shipment of the product bearing the amended label constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).

## **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

The maximum application rate for metered devices is 0.000476 lb Pyrethrins per 1000 cubic feet. No for use in outdoor residential misting systems. Do not use in residential areas. Do not use in nurseries or rooms where infants, ill or aged persons, or pets (particularly birds and fish) will be confined.

This product is designed for use in an automatically timed dispensing cabinet. Use metered valve provided, which gives a dosage of 64 mg (0.0022 oz). The dispenser should be installed 7 ft above the floor, at least 3 ft from solvent-sensitive surfaces (plastic, painted or varnished surfaces) and 12 ft from any surface that may come in contact with food (including, but not limited to, countertops, appliances, equipment and utensils). In food-processing areas, the dispenser may be activated only when the facility is not in operation. Do not place metering device directly over or within 8 feet of exposed food, dishes, utensils, food processing equipment, and food handling or preparation. Do not install within 3 feet of air vents. Carefully follow directions for the dispenser unit when installing the dispenser and replacing cans or conducting maintenance. Foods must be

removed or covered during treatment. All utensils, shelving, etc. where food will be handled should be covered or removed before treatment or thoroughly washed with an effective cleaning compound followed by a potable water rinse prior to use.

Controls *FLIES, MOSQUITOES, GNATS and FLYING MOTHS* in an area of 6000 cubic feet (approximately 25x25x10 ft) in dairies, barns, canneries, breweries, manufacturing plants, restaurants, hospitals, stores, motels and other public buildings (banks, factories, warehouses, churches). Factors such as shape of area, temperature, humidity, air currents and sanitary practices all affect insect activity and may modify the area protected. Do not use in aircraft cabins except in compliance with PR Notice 96-3. When used in dairy barns or facilities: Close milk bulk tank lids to prevent contamination from spray and from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking.

**TO USE:** Following the instructions on the dispenser, insert the container and set it to discharge at 15 minute intervals, 24 hours a day or between specific hours. Sprayed around the clock at 15-minute intervals, this container will last for 28 days.

If any insecticide remains in the can when it is scheduled for replacement, it may be dispensed manually. Spray directly at flies or other insects, pressing actuator button repeatedly, or use as a space spray. Close windows and doors and press actuator button 7 times per 1000 cubic feet of space. Keep can in motion, and pointed slightly upward to distribute the spray in the upper portion of the room. Do not remain in the treated area. Exit area immediately and remain outside the treated area until aerosols, vapors and/or mist have dispersed.

**SPACE SPRAY RESTRICTIONS: Except when applying with a metered-release device,** do not enter or allow others to enter until vapors, mists and aerosols have dispersed, and the treated area has been thoroughly ventilated; do not apply this product in a way that will contact workers or other persons, either directly or through drift; and only protected handlers may be in the area during application. Do not make space spray applications when facility is in operation. Prior to space spray applications, cover or remove food, and cover food-processing surfaces or clean after treatment and before use. The maximum metered-release device space spray rate for food-handling establishments is 0.005 lbs Pyrethrins per 1000 cubic feet.

Do not use in occupied rooms. All persons must be removed from rooms prior to treatment. Rooms should be ventilated for two hours after spraying. Do not allow persons to re-enter room until after ventilation.

The maximum application rate for metered release devices is 0.000476 lb Pyrethrins per 1000 cubic feet. Not for use in outdoor residential misting systems.
