

**FIRST AID**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

To repel insects listed on the front panel, hold can at least 12 inches away. Point opening in desired direction and press top to spray. **Do not spray in enclosed areas. Do not use under clothing. Use just enough repellent to cover exposed skin and/or clothing. Avoid overexposure. Frequent reapplication and saturation is unnecessary for effectiveness.** For chiggers, also apply to shoe

tops, socks and around openings of clothing.

After returning indoors, wash treated skin with soap and water. Wash treated clothing.

Do not apply over cuts, wounds or irritated skin. Do not spray directly on face. To apply to face, spray into hands and rub on. Do not apply near eyes or mouth. Apply sparingly around ears. **Do not use on children under 2 years old.** Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, discontinue use, wash treated skin and call your local poison control center. If you go to a doctor, take this repellent with you.

Avoid contact with plastics such as eyeglass frames and such fabrics as acetate rayon, spandex or other synthetics (other than nylon).

**STORAGE:** Store in a cool, dry place away from heat or open flame. Do not contaminate water, food or feed by the use, storage or disposal of this product.
