



CRACK AND CREVICE INJECTION USE ONLY

For Roaches: German, American, Oriental, Brown Banded

Whitmire's Prescription Treatment Spot Residual is for use only with injection tube and for injecting into cracks and crevices where these insects may be hiding, living, and breeding.

Place injector tip 1/2" into cracks, crevices, holes, and other small openings where the above insects may be a problem. Release approx. 1 second spray per spot. In serious infestation, if possible, place spots approx. 12" apart. In light infestation or preventive treatment, place spots approx. 3 feet apart.

APPLICATIONS WITHIN FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS

Limited to Crack and Crevice Treatment Only — Apply a small amount of material directly into cracks and crevices such as expansion joints between different elements of construction or between equipment bases and the floor, wall voids, motor housing, junction boxes or switch boxes, conduits or hollow equipment legs where roaches (German, American, Oriental, Brown Banded) hide. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces.

Applications of this product in the food areas of food handling establishments, other than as a crack and crevice treatment, are not permitted.

WARNING: Keep out of reach of children. Contents under pressure. Do not puncture. Do not use or store near heat or open flame. Exposure to temperatures above 130 F may cause bursting. Never throw container into fire or incinerator.

May be harmful if swallowed, inhaled, or absorbed through the skin. Avoid breathing of spray mist and provide adequate ventilation of area being treated. Contact with skin, eyes, or clothing should also be avoided. Wash thoroughly after using.

Avoid contamination of food, utensils, and food preparation areas.

Should illness occur, get prompt medical aid. To Physician — Atropine sulfate is antidotal.
