

PT* 555 d-trans Allethrin **Insect Fogger**

SANITATION

This is the first step and most important of any insect control program.

Clean up all spilled foods, garbage. Clean all surfaces. Scrub garbage cans so they do not give off odors (gases) that attract insects.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. FLYING INSECTS. Files, Mosquitoes, Gnats, Small Flying Moths, Fruit Files, Close all windows and doors and direct fog upward at a rate of 1 to 3 seconds per 1000 cubic feet. Disperse in all locations. Keep area closed for 15 minutes.

GRAIN WEEVILS. FLOUR BEETLES, CHOCOLATE MOTHS, CARPET BEETLES, DRUG ! STORE BEETLES in exposed adult and larvae stages. Contact as many insects as possible when freating infested areas such as cracks, crevices, stored products, machinery, and dark secluded areas. For Carpet Beetles, treat infested area of carpets, localized areas of floors, baseboards, and into cracks and under carpets where these pests may be found Spray 10 to 20 seconds per 1000 square feet of floor space. Repeat treatment weekly or as insects appear

ANTS, SILVERFISH, CRICKETS. Hold aerosol close to cracks and mist directly into them confacting as many insects as possible. Apply freely in all possible hiding places behind baseboards, sinks, cabinets, coffee makers, meter boxes, manholes. Pepeat all treatments as necessary

CRACK AND CREVICE APPLICATION

For direct spray into cracks and crevices, use Whitmire Crack and Crevice Equipment. ROACHES, WATERBUGS: To flush insects for inspection purposes only, hold aerosol close to cracks and mist directly into them. Apply freely in all possible hiding places behind baseboards, sinks, cabinets, coffee makers, meter boxes, into wall and equipment voids and into manholes and drains
