

To Kill Brown Dog Ticks and Fleas:

Spray the animal from a distance of 8 - 12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under the body. As you spray, fluff the hair so the spray will penetrate to the skin. Make sure spray wets ticks thoroughly. Do not spray into the face, eyes, or on genitalia. Repeat as needed.

Do not spray on nursing puppies or kittens.

For Pet Bedding and Resting Areas:

Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters, nearby cracks and crevices, along and behind baseboards, window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry area. Keep container closed.

Disposal: Do not reuse empty container. Wrap container and

put in trash collection.
