Release approximately one half to one-second of product. Concentrate treatment at insect activity sites. For light infestations, a minimum of 4 - 6 bait points is recommended per 100 sq. feet of treatment area. For heavy infestations, a minimum of 12 - 24 bait points is recommended per 100 sq. feet of treatment area. For inaccessible voids drill small holes and inject PT 300. Repeat as necessary.

Do not use in the food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is
