In accordance with the Resmethrin Registration Standard, modify your Environmental Hazards statement to read as follows:

"This pesticide is highly toxic to fish. Do not apply directly to water. Drift and runoff from treated sites may be hazardous to fish in adjacent waters."

This will also acknowledge receipt of the revised basic formulation for the subject product. This amendment is acceptable and a Confidential Statement of Formula has been placed in the respective file.

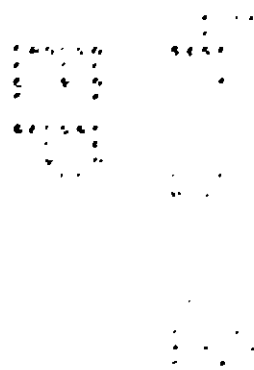

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Shake well before each use. Remove protective cap. Aim spray opening away from person. Push button to spray.

OUTDOORS - TO CONTROL NUISANCE PESTS:

Ants: Spray trails, nest and points of entry. Spray on ants where possible. Repeat as necessary.

SPIDERS, INCLUDING BLACK WIDOW AND BROWN RECLUSE: Spray directly on spiders and web.

WASPS AND HORNETS: Stand safe distance, 6-12 feet from nest and not directly underneath. Aim actuator opening at nest with wind at your back. Spray until nest is thoroughly wet. Hit wasp and hornets on nest when possible. Best time to spray is in early morning or in evening, since wasps and hornets congregate on or in nest at night. Do not apply to pets or contaminate food, foodstuffs, dishes or utensils. For outdoor use only. Not a space spray.

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Wash hands after use. Cover or remove exposed foods. Avoid contamination of cooking utensils and food preparation surfaces. Do not spray animals. Remove pets, birds and cover fish aquariums before spraying. Do not use on food crops.

In case of eye contact, flush eyes with plenty of water. Get medical attention if irritation persists.

ENVIRONMENTAL HAZARDS

Keep out of lakes, ponds or streams. Do not contaminate water by cleaning of equipment or disposal of wastes. When used on surfaces, do not wash or flush freshly sprayed surfaces into adjacent waters.
