CAUTION

Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists.

Do not use this product on any edible crop. Remove pets and birds, and cover fish aquariums before spraying.

To Kill Ornamental Plant Pests Listed Below: When sprayed directly on insects, this spray will kill the insects listed. Caution should be taken when spraying new tender growth on young plants.

WHEN SPRAYING, HOLD CAN 18-24 INCHES FROM PLANT.

For best results, spray in the evening or on a cloudy day when air is still. Mist the plants lightly. Use a slow sweeping motion. Avoid wetting foliage with spray. Spray rows at the rate of one foot per second. For heavy growth spray both sides of row. Repeat as needed.

Do not spray when temperature exceeds 90 F. Stand upwind while spraying.
