Dear Ms. Thomas:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

<u>Indoor Treatments section, Bed Bugs subsection comment(s) on Container Label, page 3 of 8:</u>

1. Since no registrants are supporting the use of boric acid in any broadcast carpet, rug or upholstery applications, replace this subsection with the following:

"BED BUGS: Apply Whitmire PT® 240 PERMA-DUST® Insecticide as a crack & crevice or spot treatment where evidence of bed bugs occurs. This includes bed frames, box springs, inside empty drawers and clothes closets, night stands and other non-upholstered furniture in the room, floor moldings, window casings, wall voids, behind wall hangings, wallpaper edges and popcorn ceilings. Take bed apart. Treat joints and channels if hollow, such as square or round tubing, and see that interior framework is treated. Bed bugs may also harbor in areas of the room away from the bed. Do not use Whitmire PT® 240 PERMA-DUST® Insecticide on mattresses, pillows, bed linens, clothes, carpets or upholstery. Not recommended for use as sole protection against bed bugs. If evidence of bed bugs is found in/on mattresses, carpet or on upholstery, use products approved for these uses. Allow all treated areas to dry thoroughly before use."

2. The directions for applying the product to kill bed bugs are acceptable except that the duration of a wall void injection should be specified. State a re-treatment interval or directions indicating when a re-treatment might be necessary.

4. Since no registrants are supporting the use of boric acid in any broadcast carpet, rug or upholstery applications, replace this subsection with the following:

"BED BUGS: Apply Whitmire PT® 240 PERMA-DUST® Insecticide as a crack & crevice or spot treatment where evidence of bed bugs occurs. This includes bed frames, box springs, inside empty drawers and clothes closets, night stands and other non-upholstered furniture in the room, high and low wall moldings (such as floor molding or window casings), wall voids, behind wall hangings, wallpaper edges and popcorn ceilings. Take bed apart. Treat joints and channels if hollow, such as square or round tubing, and see that interior framework is treated. Bed bugs may also harbor in areas of the room away from the bed. Do not use Whitmire PT® 240 PERMA-DUST® Insecticide on mattresses, pillows, bed linens, clothes, carpets or upholstery.
