The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Pyriproxyfen and Permethrin Interim Decisions, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

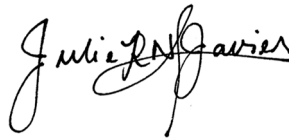

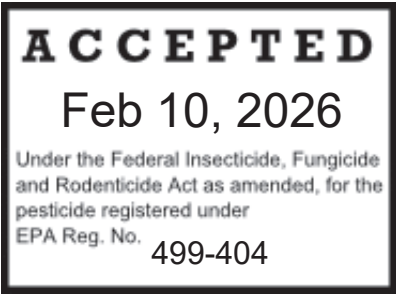

Product Information

This product kills fleas and prevents flea infestations for a full season. Adult fleas may be seen in treated areas when brought in on infested animals or when adults emerge from pupal cases; however, a population will not develop in the treated areas.

In transportation equipment, certain plastics may be whitened or dulled. Apply only to carpets and cloth upholstered areas, or test an inconspicuous area before applying.

Application Instructions

SHAKE WELL before use.

DO NOT treat pets, including cats and dogs, with this product.

Cover aquariums and fish bowls, and remove birds from area prior to application.
