

Pyriproxyfen is an insect growth regulator(IGR) that prevents the development of the immature stage of the insect or limits the reproductive capability of the individual if it should reach adulthood. Little or no adult kill should be expected from an application of TC 148b.

This product may be tank mixed with an approved adulticide. For any mixture check for phytotoxicity before contacting plants with the mixture.

Apply pyriproxyfen (Distance) (TC 148b) no more than two times per cropping cycle or no more than two times per six months.

If a high population of adult insects is present, the use of an adulticide may be necessary for immediate relief.

Mixing Instructions

Thoroughly clean spray equipment before using 148b. Shake concentrate well before diluting. When diluting, first add approximately one-half of the water to the spray tank and then add the proper amount of 148b. When emptying the bottles triple rinse with water, shake well and add the rinsate to the spray tank. Add the rest of the water and agitate the sprayer thoroughly. Agitate sprayer occasionally during use to insure even mixture. Shake or reagitate sprayer if spraying is interrupted or if dilution is left in sprayer overnight. If spray screens are used, they should be 50 mesh or larger.
