The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cyfluthrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product's label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA's Office of Enforcement and Compliance Assurance.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must

submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 12 months from the date of this letter. After 12 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

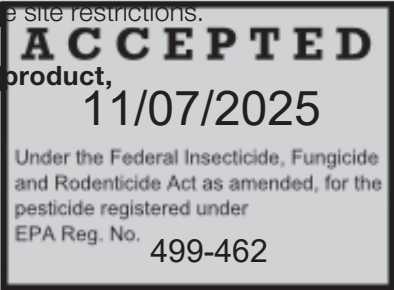

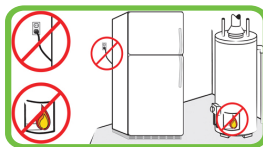
- **DO NOT** use in small, enclosed spaces such as closets, cabinets, or under counters or tables. **Use of a fogger in an enclosed space may cause the product to explode, resulting in injury to people or damage to property.**



- **DO NOT** use in a room 5 feet x 5 feet with an 8 foot ceiling or smaller. Instead, allow fog to enter from other rooms.

Application Instructions

- Point valve and can **AWAY** from face and eyes. The container sprays straight up.
- Press tab down in locked position to initiate application.
- Turn off **ALL** ignition sources such as pilot lights (shut off gas valves), other open flames, or running electrical appliances that cycle off and on (e.g., refrigerators, thermostats). **Call your gas utility or management company if you need assistance with your pilot lights.**



Before You Fog:

Close all outside doors and windows. Shut off fans, air conditioners, and ventilation equipment. Open cabinets, cupboards, drawers, closets, and doors in areas to be treated.

Put out all flames, pilot lights, and other ignition sources.

Remove pets and birds. Cover and turn off fish aquariums and associated air flow systems before application.

Remove or cover exposed foods, dishes, utensils, food processing equipment, and surfaces. Thoroughly wash before use following treatment.



COVER waxed wood floors, waxed furniture, and stereo or other electronic equipment. Cover with plastic dust covers (or newspaper) in the immediate area surrounding the fogger.

To Start Fogging:

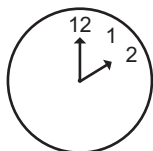
Place a chair, table, or stand in the center of the room to be fogged. Cover with several layers of newspaper, paper towels, or plastic tarp. Set fogger on covered stand. This

promotes dispersement in all locations contacting as many insects as possible.

Immediately vacate the treated house, individual apartment unit, or other structure immediately. **DO NOT** remain in the area during treatment. **DO NOT** reenter for 2 hours.

Airing Out:

Wait 2 hours after application (until aerosols and vapors have dispersed), then ventilate the treated area by opening windows, vents, and doors for 2 hours before reoccupying. If an odor is still detected, additional ventilation is required before reoccupying.



DO NOT Re-Enter for two hours.

STORAGE AND DISPOSAL

DO NOT contaminate water, food, or feed by storage or disposal.

Pesticide Storage

Store in a cool, dry area away from heat or open flame and inaccessible to children or pets. Store away from food and pet food.

Pesticide Disposal
