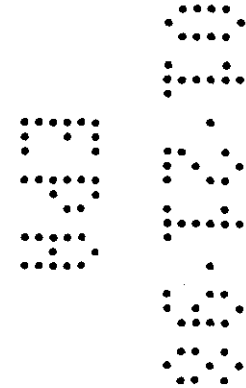

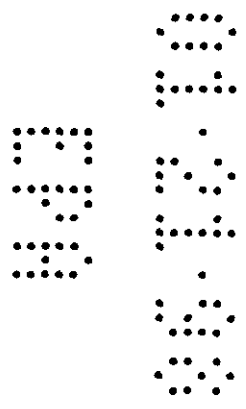
1. Break baits apart from the plastic frame. (Alternate Directions: Remove bait from container.)
2. For thorough roach control, use as many baits as necessary to achieve good coverage and control of the existing infestation for the treated area.
3. For best results, place the baits next to the wall along baseboards, in corners, under sinks, in cabinets and near plumbing fixtures. Use under and around equipment and appliances. If possible place in voids.
4. Baits work best on horizontal surfaces touching corners and walls. If you apply a bait on a vertical surface, use the enclosed stickers.
5. Replace baits when necessary, approximately every 3 months.

APPLICATIONS IN FOOD HANDLING ESTABLISHMENTS: Places other than private residences in which food is held, processed, prepared or served.

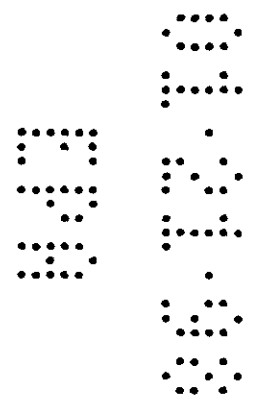
