- c. Add the statement "Not for Use in Federally Inspected Meat and Poultry Plants." This statement must remain on the label until you receive authorization from USDA to use the product in the non-food/feed areas of these plants.
- d. On page 2, add a triple asterisk to the following sites: commercial buildings, food handling establishments, food processing plants, food storage areas, hotels, motels, restaurants, storage areas, supermarkets, and warehouses followed by the statement:

 *** non-food/feed areas only
- e. Since the product is intended for commercial use only, add to the front panel "For Pest Control Operators and Commercial Use Only."
- f. Delete the statement "Do not apply directly to dogs or cats" since it conflicts with the statement "Remove pets and birds...etc."
- 3. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

Use Pro-Control Inspector for insect infestations in apartments, attics, basements, buses, cabins, campers, commercial buildings, food handling establishments, food processing plants, food storage areas, garages, hospitals*, hotels, houses, kennels, motels, nursing homes*, office buildings, railroad cars, restaurants, schools**, sheds, ships, storage areas, supermarkets, truck trailers, warehouses, zoos. *Remove patients before using. After treatment ventilate rooms for 30 minutes before returning patients to rooms. **Do not apply when children are present.

DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where foods may be prepared or held. Foods should be removed or covered during treatment. Avoid contamination of food and foodstuffs. When used as a space spray, apply only when plant is not in operation. After treatment, food contact surfaces and equipment must be washed with an effective cleaning compound followed by a potable water rinse. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use.

Nonfood/nonfeed areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Ants, Boxelder Bugs, Centipedes, Crickets, Earwigs, Firebrats, Millipedes, Palmetto Bugs, Pillbugs, Roaches, Scorpions, Silverfish, Sowbugs, Spiders, Ticks, Waterbugs: Place wand tip approximately 1/2 inch into crack and mist directly, contacting as many insects as possible. Apply freely in all possible hiding places; behind baseboards, sinks, cabinets, refrigerators, dishwashers, under counters. Move tip along while spraying in long running cracks. Do not apply directly to dogs or cats.

Flies, Fruit Flies, Gnats, Indian Meal Moth, Mediterranean Flour Moth, Midges, Mosquitoes: Close all windows and doors and direct spray upward at a rate of 1-3 seconds per 1000 cu. ft. Disperse in all directions. Keep area closed for 15 min. Open and ventilate before reoccupying.

Fleas in buildings: Close all windows and doors. Hold 36 inches above floor and direct spray toward floor and lower walls at a rate of 10 sec. per 100 sq. ft., making sure that all floor and upholstered surfaces are contacted. Repeat treatments after 7 days or as necessary.

Cadelle, Cigarette Beetles, Confused Flour Beetles, Dermestid Beetles, Granary Weevils, Hide Beetles, Larder Beetles, Lesser Grain Borers, Mealworms, Merchant Grain Beetles, Red Flour Beetles, Rice Weevils, Sawtoothed Grain Beetles, Warehouse Beetles: Remove all utensils, uncovered food stuffs (or any with package opened), shelf paper and other objects before spraying. Allow treated surfaces to dry and cover shelves with clean paper before replacing any utensils, foodstuff or other items. Any foodstuff accidentally contaminated with spray dilution or foodstuffs infested with pests should be removed and discarded. Contact as many insects as possible when treating infested areas such as cracks, crevices, stored products, cartons, containers, machinery and dark secluded areas. Spray 20 sec. per 1000 cu.ft.of space. Repeat treatment weekly or as necessary.

Hornets, Mud Daubers, Wasps and Yellow Jackets: Spray mist directly on insects and their nests from approximately 2 foot distance. Insects contacted will fly away from fog. Application should be made in late evening while insects are inactive.

STORAGE AND DISPOSAL

STORAGE: Store away from heat or open flames in an area inaccessible to children.

DISPOSAL: Do not reuse empty container. Wrap container and put in trash. Do not puncture or incinerate.

with skin, eyes, or clothing. Wash thoroughly after handling. Do not remain in enclosed areas after use. Avoid breathing vapors. When used as a space spray, ventilate enclosed area before returning. Avoid contamination of food and foodstuffs. All food preparation surfaces should be covered during application and thoroughly cleaned before use. Apply only when no food is being prepared. Remove pets and birds, cover and turn off fish aquariums before spraying.

DESCRIPTION OF PRODUCT:

This product can also be sold with a two-way crack & crevice wand assembly, which allows the product to be sprayed as a fine mist with the wand in the downward position or through the wand as a coarser spray in the fully extended position. Following are the specific 'directions for use' for the use of this actuator. The remainder of the label is the same as above.

This product is designed for either space spray or crack & crevice application .

For space spray use: Wand assembly should be in the downward position.

For crack & crevice use: Wand assembly should be fully extended outward from the can.
