#### FIRST AID

## DIRECTIONS FOR USE IT IS A VIOLATION TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

TC 179 Flea Killer and Insect Growth Regulator kills fleas and prevents flea infestations for up to 7 months. Adult fleas may be seen in the treated areas when brought in on infested animals or when adults emerge from pupal cases. However, a population will not develop in the treated area.

Use TC 179 at the rate of one can (9 fluid oz.) for up to 2,100 sq. ft. Carpeted areas may be vacuumed before treatment and after space treatment has dried. Treat infested areas or areas which could be infested; these include rugs, carpets, upholstered furniture, pet beds and pet resting areas. Hold can at arms length and approximately 36 inches away from the surface being treated. Use a sweeping motion to apply product and then vacate treated area. An area of 80 - 100 sq. ft. can be treated in approximately 10 seconds with TC 179. When treating upholstered furniture, treat areas where flea development occurs including under cushions and beneath furniture.

Because of the wide variety of floor types and finishes, treat a small inconspicuous area before treating the chilf area. Avoid spray contact with antique finishes.
