Enclosed in support of this action is a completed application (EPA Form 8570-1) and two copies revised labeling (one is highlighted for easy reference and review).

We are adding the alternate brand name, Beethoven™ TR, and descriptor "Miticide/Insecticide".

The enclosed label also includes the revisions required by EPA with the Notice of Pesticide Registration dated July 31, 2009.

This notification is consistent with the provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46, and no other changes have been made to the labeling or the confidential statement of formula of this product. I understand that it is a violation of 18 U.S.C. Sec. 1001 to willfully make any false statement to EPA. I further understand that if this notification is not consistent with the terms of PR Notice 98-10 and 40 CFR 152.46, this product may be in violation of FIFRA and I may be subject to enforcement action and penalties under sections 12 and 14 of FIFRA.

Control of target pests is best achieved before populations reach economically damaging levels. Use an alternative class of chemistry in a continuing treatment program to prevent or delay pest resistance.

USE RESTRICTIONS

- Do not use this product in greenhouses with unvented or defective gas heating systems or when open combustion exists.
- Do not proceed with application if plants are under stress, such as but not limited to, extreme temperatures and humidity created by tightly closed greenhouses.
- Do not use on crops grown for food or feed.
- Do not make more than 2 applications per crop cycle or within a 6 mo period of time.

AGRICULTURAL USE REQUIREMENTS

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application. For any requirements specific to your State or Tribe, consult the State or Tribal agency responsible for pesticide regulation.

Use this product only in accordance with its labeling and with the Worker Protection Standard (WPS), 40 CFR Part 170. This standard contains requirements for the protection of agricultural workers on farms, forests; nurseries and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE), restricted-entry interval (REI) and notification to workers (as applicable). The requirements in this box only apply to uses of this product that are covered by the Worker Protection Standard.

Do not enter or allow worker entry into treated areas until after the REI of 24 hr (with no ventilation). Early entry to treated areas is permissible after 4 hr (per 40 CFR 170.112) to perform short-term activities, such as ventilation procedures, provided personal protective equipment is worn as specified below. You may ventilate the treated areas per 40 CFR 170.110(c)(3) after 4 hr (i.e. 10 air exchanges are completed; or 2 hr of ventilation using fans or other mechanical ventilating systems; or 4 hr of ventilation using vents, windows or other passive ventilation). The REI is equivalent to completion of ventilation (as described above) or 24 hr (with no ventilation) and no PPE is required after this time.

Notify workers of the application by warning them orally and by posting warning signs outside all entrances to the greenhouse.

PLANT SAFETY INFORMATION: This product has been tested on a wide variety of plants and in our opinion has demonstrated excellent plant safety. However, not all varieties or strains of the plants listed have been tested. Therefore, before treating a large number of plants, treat a few plants and observe for plant damage and for performance prior to full scale application.

Growers should collect a variety of sample plants, flowers, foliage or omamentals of concern, place them in an empty greenhouse (or designated testing area) and activate one can of product per the Directions for Use.

PREAPPLICATION DIRECTIONS: For best results, apply during early evening when foliage is dry and greenhouse temperature is between 60° – 80°F. Keep canister at room temperature (about 65°F). Shut off all exhaust fans and close all windows, doors and ventilators. Turn off all ignition sources such as pilot lights (shut off gas valves), other open flames or running electrical appliances that cycle off and on. Prepare a 3 ft plant free zone in which to place canister(s). Elevate canister(s) above the top of plants; common practice is to place the canister(s) on a stool or overturned pot to elevate it. Place cans evenly throughout the area to be treated, positioned to allow uninhibited release. To treat hanging baskets, an empty basket can be used to hold the canister and elevate it to the hanging basket level. Low volume horizontal air flow may help optimize performance.

TOTAL RELEASE DOSAGE

Apply product when pest (or plant damage typical of an indicated pest) is seen.

The total release canister will dispense the entire contents of the can in about 2 min. Thorough coverage is achieved by the normal air movement within your greenhouse. The chemical will move around and throughout the plant foliage due to the small particle size produced, and the normal ebb and flow movement of the air. Both top and bottom of the plant foliage is covered with particles.

Master Label v1.1 (11/17/09; dmt)

Use one 2 oz can/3,000 ft² (25,000 – 50,000 ft³). For greenhouses with numerous hanging baskets or tough-to-control insects, it is permissible to use 2 cans per 3,000 ft² (25,000 – 50,000 ft³). For smaller greenhouses, use one can per 1,500 ft² (12,000 – 25,000 ft³).

TO ACTIVATE CANS: Hold the canister away from you and depress the actuator until it is locked down. Place the canister in the plant free zone and leave the treatment area. If activating more than 1 canister in the treatment area, start at the far end of the area, opposite from the exit door, activating and placing cans as you move across the area until you have reached the exit door.

Once all cans have been activated, immediately leave the treatment area and close the door. Use low volume horizontal air flow or have fans off for a minimum of 4 hr or all night if possible.

Bedding plants (such as): impatiens, marigolds, petunias, geraniums and garden mums

Cut flowers (such as): roses, chrysanthemums, carnations, snapdragons and orchids

Flowering hanging baskets (such as): fuchsia, lantana, New Guinea impatiens, ivy and geraniums

Foliage (such as): Boston fern, dracaena, ficus, schefflera and philodendron

Potted flowering plants (such as): poinsettia, chrysanthemums, florist's azaleas, lilies, African violets, geraniums, hibiscus, kalanchoes and begonias

Ornamentals (such as): azalea, barberry, cotoneaster, euonymus, ilex, juniper, oak, pine, rhododendron, roses, spiraea, spruce, viburnum and yew
