- 1 Delete all text throughout the label marked with strikethrough
- 2 All label language related to the proposed use of this total release fogger (TRF) product in non-food areas of food handling establishments (FHEs) must be removed from the subject label. Whitmire Micro-Gen Research Laboratories. Inc. did not submit any dinotefuran residue data to support this use site. Use of a fogger in the non-food areas of a FHE can result in dinotefuran residues in food areas.


