

- 1. Make the following label changes:
 - a. Revise the EPA Registration Number to read, "EPA Reg. No. 499-565"
 - b. Add the following statement to the Use Restrictions: "Do not use indoors". Also, revise the first statement to read "Do not use within 1 foot of the drip-line of any edible plants."
 - c. After the last sentence in the 'Outdoor Surface Treatment' section of the Directions for Use, add the following statements: "Do not allow this product to contaminate or come into contact with surface waters through application or drift. Treatments to nests, trails, and points of entry on or near structures must be spot treatments only. Do not apply this product in any area-wide manner for outdoor general insect control away from structures."
- 2. Submit and/or cite all data required for registration/reregistration of your product when the Agency requires all registrants of similar products to submit data.
- 3. Within sixteen (16) months of the date on this Notice of Registration, provide to the Agency acceptable data packages for Guideline Studies as follows:
 - a. OCSPP 830.1600, (Description of Materials), OCSPP 830.1650 (Formulation Process), OCSPP 830.1800, and (Enforcement Analytical Method). The Agency's Product Chemistry Review is Attached. If acceptable data is not submitted within 16 months of this NOR, this registration will expire on March 7, 2014.

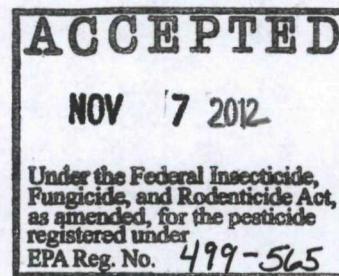

This product is a ready-to-use, pressurized insecticide for perimeter and outdoor surface application. Apply using the BASF application wand (sold separately). [Alternate text: One 2 lb can treats 1,735 – 1,800 ft². One 20 oz can treats 1,140 – 1,200 ft².]

Attaching the Application Wand

- 1) Ensure the valve on the wand is in the "Off" position.
- 2) Attach the can clamp by squeezing it together and place it over the stem valve, then release. The "foot" or clamps should be down.
- 3) Place the can on a flat surface.
- 4) Place the valve clamp adaptor into the opening of the can clamp.
- 5) Screw the can clamp on counterclockwise until snug.

Moving the Application Wand From One Can to Another

1) Turn the valve off and empty the hose, using the product according to the label. 2) Place the can on a flat surface and unscrew the can clamp in a clockwise direction while holding the valve clamp adaptor in a stationary position. 3) Remove the wand. 4) Remove the can clamp by squeezing and lifting it off the can. 5) Start from the beginning, with a new can, as directed above.

Turn the valve "On"; ensure there are no leaks.

Perimeter Treatment

Hold the tip of the wand 12 – 24" from the building and surface intersection and release product while moving at the rate of approximately 2 mph or 3 ft/sec. Treat 1 ft up the structure and 1 ft out from the structure. A single pass should suffice if the wand is held in the proper position and distance from the surface.

Outdoor Surface Treatment

Apply as a band ≤ 18" wide where listed pests enter the structure, where they trail or crawl and hide or where their nests are found (i.e. around doors, windows, vents, pipes or points of water or utility entry, where the siding meets the foundation, or other exterior openings) by moving the wand 2 - 3 ft/sec. Treat weep holes by injecting product for 0.25 - 1 sec.

STORAGE & DISPOSAL
