Apply when grass leaves are dry. Always repeat at 5-7 day intervals. Continue 'till plants are dead. Plants will be dead 4-5 days after last required treatment. If extreme heat prevails, late afternoon applications reduce possible turf discoloration. Soil should be moist before treatment. Resume keeping soil moist day after application and especially during hot dry weather if possible.


TURF APPEARANCE: if correct rate and coverage was employed, Dallis Grass should start to lighten in color within 3 days and some browning occur at edge of leaf. If not, check rate used and coverage per gallon obtained and make needed correction on subsequent applications. Severe browning of all turf indicates excess rate was used. Continue applications at lighter rates.

NEW LAWN: Do not treat until after third mowing.

CAUTION: Avoid breathing spray mist. Avoid contamination of feed and foodstuffs. Keep away from children and domestic animals. Keep livestock off treated areas. Use on grass only. Avoid contact with skin and wash hands after using. Harmful if swallowed. Keep children and animals off treated areas until material is washed into soil. Do not contaminate waters used for domestic purposes or irrigation.

ANTIDOTE: If taken internally induce vomiting and call physician at once.
