

### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**For Control of Wasps and Hornets:** It is preferable to apply this product in late evening when all wasps and hornets have returned to the nests and are at rest. Point valve opening away from face. Making sure the wind is at your back, aim spray at the nests and depress the button, continuing to spray until the nests are wet. Repeat as necessary. Can also be used in attics and other areas where nests are found. Do not attempt to spray insects while in flight.

**STORAGE:** Store in a cool area away from heat or open flame. **DISPOSAL:** Replace cap, wrap in newspaper and discard in trash. Do not puncture or incinerate.

### **PRECAUTIONARY STATEMENTS**

#### **Hazards to Humans & Domestic Animals**

**CAUTION:** Harmful if swallowed. Avoid inhalation of vapors. Avoid contact with skin and eyes. Do not use in commercial food processing, preparation, serving or storage areas. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Cover exposed food. Remove pets, birds and cover fish aquariums before spraying.

#### **Statement of Practical Treatment**

#### **Physical or Chemical Hazards**
