Dear Ms. Davis:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide. Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1) Please reinstate related compounds plus percentage for permethrin in the ingredient statement. These related compounds still appear on the labeling for your source products and it's active/inert status has not been determined.
- 2) Reinstate the asterisk and cis/trans ratio for permethrin since the toxicity of this chemical varies by ratio.
- 3) Please remove all "repeat treatments as necessary" statements and provide the minimum amount of time between applications. This should be based on the efficacy data of the product you cited.

We could not find any efficacy data in your file for the following pests: cockroaches, Brown Dog Ticks, fleas, mosquitoes and flies. Please submit or cite (with MRID numbers) accepted data for all of the above insects with your final printed labeling or remove them from your label.
